Section IV Assessment 3 – Narrative Pedagogical and Professional Knowledge, Skills, and Dispositions (Planning)

1. Description of assessment and its use in the program

This assessment is a three-part performance evaluation (See **Attachment A**) that requires teacher candidates to plan and implement lessons based on each of the NCSS Ten Themes. For this assessment, the relevant element of the lesson is the planning associated with the content knowledge inherent in a particular theme (Element 1). This assessment is used to determine the level of planning that is required to plan an effective lesson aligned with a specific standard. The assessment has a simple rubric allowing the assessor (usually the college supervisor) to determine whether the teacher candidate provides evidence that the teacher candidate addresses the relevant standard contained in the lesson because she/he:

- has knowledge of his/her students
- uses appropriate resources
- demonstrates knowledge of content and its relevant pedagogical practice
- creates relevant behavioral objectives/activities

The rubric has three levels of performance: Unacceptable is scored as 1, Developing as 2, and Acceptable as 3. A score of three is the desired goal. (**See Attachment B**)

2.Description of how this assessment specifically aligns with the standards

This assessment aligns specifically with each of the content standards (Ten Themes). By focusing on the specific theme, the teacher candidate must plan for instruction in the course in which he/she is student teaching and integrate the specified theme into the course curriculum. Because the Ten Themes can be easily integrated into any Social Studies curriculum, this is especially beneficial to teacher candidates preparing for broad-field secondary Social Studies certification. Teacher candidates must be knowledgeable in the content of the disciplines represented by the Ten Themes and must know how to plan for meaningful instruction based on his/her knowledge of students, available resources, and the creation of relevant behavioral objectives and activities. Also important is the ability to plan well enough to integrate the content knowledge found in each standard into their existing curriculum no matter what the Social Studies course. This may prove to be a difficult task when the teacher candidate does not teach an entire year or semester's course, but must look for opportunities where the Ten Themes can be integrated into his/her instruction.

3. Analysis of data findings

(See Attachment C)

The data for this assessment was gathered from teacher candidates during their student teaching semester in the Spring of 2006 and is arranged so that results can be seen from two perspectives—scores per standard and scores per teacher candidate. Looking at the data on the scores per standard, it can be noted that the range is rather small—basically straddling the #2 category (Developing). Standard 1.7 has two missing entries because teacher candidates either did not submit a lesson or it was not at all aligned with the standard. The highest scores by standard are 1,5, 1.6 and 1.8. There does not seem to be a clear correlation among those standards. The lowest scores are found in Standards 1.9 and 1.10, again with no clear correlation between the standards.

The scores per teacher candidate for planning are impacted for Teacher Candidates #1, and 10 who either did not submit two lessons with standards aligned to specific themes or the lessons the lack of alignment did not allow assessment. The higher scores (3.0) are from teacher candidates who are high achievers in both content and pedagogy. The lower scores of 1.1 and 1.2 are also reflective of less able students.

Anecdotally, the rather low scores per standard and per teacher candidate can be attributed to actual planning elements not related to content such as poor behavioral objectives and no evidence of knowledge of students and not necessarily on the pedagogy associated with specific content.

<u>4.Interpretation of how data provides evidence for meeting standards</u>

While teacher candidates are expected to create numerous lessons and units throughout their Social Studies teacher preparation program, the on-the-job, real-world environment of student teaching requires a more practical and less theoretical application. The correlation of standards with planning of effective Social Studies lessons and units needs to be closely monitored and mentored during the teacher candidates' clinical experience in order to be able to assist the teacher candidates in successful alignment with the standards. The teacher candidates seemed to struggle with certain elements of planning such as behavioral objectives and clear procedures which greatly impacted their scores based on the rubric. A solution for this would be to revise the rubric in order to separate the planning elements for purposes of scoring and to add clarity of procedures as a defining element of lesson plans. This would also allow a closer look at content in the actual lesson plan.
